

Introductions

Language and Terminology:

Language Matters:

- Use dignified, person-centered language to honor the resilience of individuals in recovery.
- Avoid outdated and stigmatizing terms like "halfway house."

The Truth About Recovery Housing:

- This is not a "halfway house" or treatment facility; it is a supportive, structured environment for mothers and their children to live.
- Designed to provide stability, healing, and the tools for long-term independence.

A Call for Compassion:

- Words can harm the broader recovery community in Carroll County.
- Stigma discourages those struggling with addiction from seeking help, perpetuating cycles of pain and isolation.⁴

Westminster Rescue Mission – A Trusted, Local Partner

A Legacy of Service:

- Faith-based
- Over 50 years serving Carroll County residents (since 1968).
- Located less than 10 minutes away on Lucabaugh Mill Road. (Thoughtfully chosen rural location promotes healing in a tranquil environment.)

Expertise in Recovery and Rehabilitation:

- CARF-accredited programming for Residential and Outpatient care.
- Services include:
 - Residential Substance Use Disorder Treatment (ASAM Levels 3.1, 3.3, & 3.5)
 - Outpatient Care
 - Recovery housing



Alignment with Community Values & Needs:

- Food insecurity addressed through the Mission Food Program, redistributing food to 26 partner organizations and offering mobile distribution.
- Engagement with dozens of churches and faith-based groups across Carroll County.
- Commitment to partnerships.



Understanding the Need: Recovery Housing for Mothers and their Children

The Challenge

- > 1 in 6 Marylanders battled a Substance Use Disorder (SUD) in the past year.1
- > 70% of women in treatment are mothers, often facing the heart-wrenching choice between pursuing recovery and being with their kids. ²
- > Carroll County lacks housing for these moms to remain with their children.

Carroll County

- ➤ Nearly 1,500 women visited the ER with a Substance Use Disorder diagnosis (2022-2023). ³
- > 87 women lost lives (2019-2023).4



The Opportunity

- Provide stable, supportive housing.
- Reduce healthcare/emergency strain.
- ➤ Offer vocational training, education.
- Keep mothers and children together for stronger recovery outcomes.

Our Recovery Residence

- ✓ Supervised
- ✓ Policies and Procedures with contact information and timely response plans
- ✓ Resident and Staff orientation includes guidance on neighbor interaction.
- ✓ Documented Courtesy Rules covering:
 - Outdoor noise and property cleanliness.
 - Vehicles, parking and shared road use.
 - Respectful behavior: avoiding loitering, offensive language, and improper smoking practices.

Creating a Safe and Supportive Space

The Program

- Goals for Mothers:
 - Employment and/or continuing education
 - Life Skills (i.e. budgeting, parenting, healthy living)
 - Independent Living
 - Sober living skills
- Maximum Capacity: 8 individuals (including live-in caretaker)
 based on zoning
- Small, focused, family-oriented: 2-4 mothers and their children
- Dedicated staffing: Live-in Caretaker, House Manager and Recovery Coordinator/Case Manager

Security measures:

- Live-in Caretaker
- House Rules & Accountability
- Good Neighbor Policy and Procedures to foster community collaboration
- Security System



Addressing Neighbor Concerns

FACTS, SAFETY & COMMUNITY IMPACT

Property and Zoning

Zoning Compliance:

- Fully compliant with existing zoning; no rezoning required.
- Functions as a supportive recovery residence, not a healthcare facility.

Capacity and Structure:

- Designed for up to 8 individuals, including 2–4 mothers and their children.
- Leverages nearby WRM services to minimize neighborhood traffic.

Property Values:

 More than 50 scientific studies found that community residences for people with disabilities, including recovery residences, do not harm property values or marketability, neighborhood turnover or safety.¹

Safety in Our Community¹

Neighborhood Safety

 Research shows that recovery homes do not increase crime rates or reduce neighborhood safety.

Positive Community Impact

- Recovery home residents actively contribute to community wellbeing through:
 - Mentoring others in recovery (63%).
 - Running or supporting local recovery groups (44%).
 - Volunteering with youth, fundraisers, and community organizations (23-32%).

Supporting Local Stability

• Residents dedicate 10+ hours/month to community involvement.

Environmental Considerations

Preservation of Landscape:

- No major changes planned to natural features
- Commitment to maintaining the serene, rural environment essential for recovery.

Animal Care and Habitat Maintenance:

- Plan to purchase and care for existing animals on the property.
- Commitment to preserving their habitats, ensuring proper maintenance.

No New Development:

- No plans for new construction (i.e. warehouses, additional, housing).
- Property will remain dedicated solely to its current purpose.

Environmental Stewardship:

• View the property as a community asset and pledge responsible stewardship.
